

# 2021 Dunn County 4-H / FFA Beef Project Entry Rules

## Members may enter the following number of animals:

NOTE: Families can weigh in together (siblings only) and may transfer animals between them but specific ownership of the animal must be declared by final weigh in.

## Market Beef Specific Entry Requirements:

**1. Entry** into the Dunn County Meat Animal Beef Market Project begins by submitting a completed and signed Project Entry form at weigh in on Saturday, February 6<sup>th</sup>, 2021 (if participating in the performance class) or to a beef representative stationed in the front office of the Dunn County Highway Department on Friday, February 5<sup>th</sup> 2021 from 8:00-10:00 AM and 2:00-4:00 PM. (If just participating in the market show).

**\*All Beef Project Entry Forms must be turned in and MAP tags checked out by the end of weigh in on Saturday, February 6<sup>th</sup> to be eligible for the 2021 Dunn County Beef Project.\***

**2. Tags:** If attending the February 6th weigh in tags will be put into your animals.

If not attending the February weigh in you must check out tags from a beef representative at the Dunn County Highway Department on Friday, February 5<sup>th</sup> from 8:00-10:00 AM and 2:00-4:00 PM.

**3.** All beef must be born after January 1 of the year previous of the exhibit year.

**4. Breeding Animal:** Project members entering beef in the Meat Animal Project must enter, exhibit and assume responsibility for daily care by May 1st of a breeding animal. Due to the

higher initial cost, first-year project members are not required to exhibit a breeding animal. For beef, a female must meet the requirements in one of the beef breeding classes.

5. Exhibitors who exhibit a dairy steer, or dairy-cross steer may exhibit in either the beef or dairy breeding show.

6. All animals must be weighed in at the Dunn County location. No exceptions. Beef will only be weighed in with a halter on and all animals must show obvious signs of castration prior to weigh-in.

**A. Identification / Loss of Ear Tag:** Each Beef project animal is required to have a Dunn County 982 RFID. This ear tag **MUST** be in place by February 6<sup>th</sup>.

**B. Loss of Ear Tag:** If an ear tag is lost on a project animal, immediately contact the Dunn County Beef Superintendents to be replaced.

**Minimum Weights and Grades:** Minimum and maximum acceptable weights and grades, *as determined by scan data*, for animals to be sold at the sale are as follows:

SPECIES	WEIGHT REQUIREMENTS	MAXIMUM PAID WEIGHT
Beef	Minimum 1100 lbs.	1500 lbs.
Dairy	Minimum 1200 lbs.	1600 lbs.
Lowline	Minimum 700 lbs.	1100 lbs.

**Live Grading Requirements: LIVE GRADING:** In the event ultrasound scan is not available:

Beef	Grade: $\geq$ Select	Minimum 1100 lbs.	1500 lbs.

Lowline	Grade: $\geq$ Select	Minimum 700 lbs.	1100 lbs.

## Beef Project – Timelines and Tips



Beef project members have offered the following timeline and tips for beef activities. This timeline can also be used as a checklist to ensure you are completing requirements.

- **September-December – Select and purchase animal**
  - Market class animals must have been born on or after January 1<sup>st</sup> of the previous year.
  - Groom the animal at least every other day after it has been purchased.
  - Be consistent when handling the animal.
- **February – Dunn County Beef Project Entry**
  - Project Entry Forms due and tags checked out by a beef representative present at the Dunn County Highway Department on **Friday, February 5<sup>th</sup>** from 8:00-10:00 AM and 2:00-4:00 PM (If not attending the following days weigh in).
  - The optional initial Dunn County Beef Weigh-In will be held **February 6<sup>th</sup>, 2021** from 9 AM – 11 AM. By attending this initial weigh in you will be eligible for total performance awards.
  - The animal's weight will depend on when it was purchased—there are no maximum weights; however, suggested maximum weight at weigh in is 800 lbs. for beef and 900 lbs. for dairy.
  - All tags MUST be in place by **February 6<sup>th</sup>, 2021** if you did not attend and tag your market animal at weigh-in.
  - All Beef Project Entry Forms must be turned in on either Friday, February 5<sup>th</sup> from 8:00-10:00 AM or 2:00-4:00 PM to a beef representative at the Dunn County Highway Department OR Saturday, February 6<sup>th</sup> at the initial weigh in, to be eligible for the 2021 Dunn County Beef Project.
- **May – Dunn County Beef Project Entry**
  - Completed and signed YQCA Certificate by **May 15<sup>th</sup>, 2021**
- **September-July—Training the animal for showing**
  - It is important to be consistent in how you work with the animal.
  - The more time that you spend with your animal, the more relaxed both of you will be in the show ring!
  - Animals that cannot be controlled by the exhibitor may be removed from the show/fair by the superintendent.

### DUNN COUNTY FAIR (WEDNESDAY, **JULY 21<sup>TH</sup>** – SUNDAY, **JULY 25<sup>TH</sup>**)

- **Check-in** – All market animals must be penned and cleaned by the end of entry time (one hour before weigh-in).
- **Wednesday 4:00 PM – Weigh-In / Carcass Scanning** (*dependent on technician availability*)

- **Wednesday by 9:00 PM –Project Posters** - Project Posters must be hung above your market steers/heifers by 9:00 pm on Wednesday.
- **Friday 1:00 PM – Beef Show**
- **1 hour after the show – Notify Superintendent which animal you will be selling**
- **Saturday 5:00 PM – Sale – Buyer’s dinner begins at 4:00 PM**
- **1 hour after the sale – Update Project Poster with buyer and sale information**
