



2021 Sheep Rules/Requirements and Tips

Market Sheep Specific Entry Rules/Requirements

1. All sheep must be born after January 1st of the exhibit year.
2. Individual members may enter up to 5 animals (wethers or ewes) and family members must declare which sibling will show which animal at the time of the fair weigh in.
3. All sheep require a Scrapie Ear Tag from farm of origin (or replacement tag in event of loss), in addition to the tag provided by the MAP project.
4. All male animals must show obvious signs of castration.
5. **Breeding Animal:** Project members entering sheep in the Meat Animal Project must enter, exhibit, and assume responsibility for daily care by May 1, 2021, of a breeding animal.
 - a. Because of the higher initial cost, first-year project members are not required to exhibit a breeding animal.
 - b. A market ewe lamb does not qualify as a breeding animal.
6. **Initial Weigh-In:** Project members wanting to participate in the Performance Meat Animal Project must weigh-in their animals on April 10, 2021 from 8:30-10:30am at the Dunn County Rec Park.
 - a. Scrapies Ear tag is required to be in place prior to weigh-in
 - b. Obvious signs of castration must be visible at weigh-in
7. **Sale/Auction/Final Weigh-in:** Sheep meeting the minimum weight of 110 lbs. will be eligible for the sale if spots are available. If sheep need to be cut, then cuts will begin with the lowest live ranking animal until the desired sale number has been reached. Final weigh-in will be on Wednesday of the Dunn County Fair at 1:00pm. Animals must be penned by noon.

Sheep Project Timeline & Tips

- January** – start watching for lamb sales, fitting clinics, feeding workshops, and other opportunities for to learn more about your project and plan your year.
- March – YQCA Training**
 - Make sure you get your YQCA online training completed and submitted by May 15, 2021.
- March-April – Select and purchase market animal(s)**
 - Market class animals must have been born on or after January 1st of the current year.

- Begin Training your animal for showing as soon as it is in your care**
 - It is important to be consistent in how you work with the animal. Petting them while they eat and sitting in/near their pen can go a long way in making them comfortable around you.
 - The more time that you spend with your animal, the more relaxed both of you will be in the show ring!
 - Handling and haltering on a regular basis will greatly increase your show success.
 - Animals that cannot be controlled by the exhibitor may be removed from the show/fair by the superintendent.
- April – Dunn County Sheep Project Entry & Initial Weigh in for Performance Project**
 - The Dunn County Sheep Weigh-In will be held April 10, 2021, from 8:30 a.m. to 10:00 a.m.
 - The animal's weight will depend on when it was purchased—there is no maximum weight; however, suggested maximum weight at weigh in is 80 lbs.
 - Completed and signed Rules Forms and Project Entry Forms due
 - If you cannot make the weigh in, Rules Forms and Project entry forms **MUST** be physically turned into the superintendent by April 10, 2021, at 10:00 a.m. Contact the superintendent (Wendy Maves, Phone: 715-828-5384) to make arrangements. You **CANNOT** send the documentation electronically.
- April** – Begin training your animal. Work on leading your animal without a halter. Proper showing is to show without a halter.
- May 1st** – Breeding stock for the fair must be under your care
- May – June** – Step up training for the show
 - This is a perfect time to clip your breeding stock and do an initial clipping of your market animals to introduce them to the clippers.
 - Haltering and walking your animal a couple times a week will really help build confidence in both you and your animals in the ring.
- May 15, 2021** – Completed and signed YQCA certificate and Species Form is due to the Fair Office. If not turned in by May 15th you will NOT be able to sell your animal in the Meat Animal Project Sale.
- July** – Prep yourself and your animals for show!
 - Sheep – Clip market animals according to fair book requirements at least 1 week prior to the show and trim hooves if needed
 - Project Member – Make sure to have proper attire as outlined in the fair book for the show.

DUNN COUNTY FAIR (WEDNESDAY, JULY 22 – SUNDAY, JULY 26)

- Check-in** – All market animals must be penned and cleaned by the end of entry time (one hour before weigh-in).
- Wednesday 1:00 PM – Weigh In / Carcass Scanning** (*dependent on technician availability*)
- Wednesday by 9:00 PM – Expense sheets due to superintendents** – Expense records must be complete and turned into the superintendents by 9:00 pm on Wednesday
- Thursday 2:00 PM – Sheep Show**
 - **1 hour after the show** – Notify Superintendent which animal you will be selling
- Saturday 5:00 PM – Sale – Buyer's dinner begins at 4:00 PM**
 - **1 hour after the sale** – Update Project Poster with buyer and sale information
- September**—Attend the Carcass Clinic
